V100'S "ONLINE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KDVV-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.v100rocks.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the V100's "ONLINE" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
